A Stallion Service Auction is held in January each year for people to bid on donated stallion services from program stallions. Funds generated from the auction (and reference sires that are paid into the program) are the source of the added purses for the Barrel Daze Futurity/Maturity and the Stallion Incentive Sidepots, which includes a large payout for the Stallion Owners. 1. **FUTURITY**—Open to horses that are foals of 2016 and younger. If the horse is registered, send a copy of both sides of registration papers. Unregistered horses must show proof of age by obtaining a veterinarian's affidavit. To enter the futurity a horse must never have competed in a barrel race prior to November 15, 2020. This excludes time only and exhibition runs. Futurity horses may compete in any type of race after November 15, 2020.
2. **CORONA CLASS**—Open to horses foaled in 2015 and 2016 that were 2020 Futurity eligible colts. NO CROSS ENTRY WITH FUTURITY. May roll to the Maturity and Open. If the horse is registered, send a copy of both sides of registration papers. Unregistered horses must show proof of age by obtaining a veterinarian's affidavit.
3. **MATURITY**—Open to horses foaled from 2013 to 2016 (age 5 to 8 years old) and may compete multiple years if age eligible. No cross entries with futurity. May roll to Open. A copy of registration papers or veterinarian's affidavit verifying age must accompany entry.
4. **RIDER**—Open to all riders. May ride more than one horse.
5. **OFFICE CHARGES/CHANGE FEES**—Office charges are included in the entry fee for both the Open Futurity (\$85) and Open Maturity (\$30) and Open Corona Class (\$50). Buy-outs (change of horse) are allowed for \$125 and the fee for late entry is \$150. Deadline for buy-outs and late entries is noon on April 9.
6. **EXHIBITIONS**—Each paid futurity entrant will receive one minute of arena time to use at his/her discretion beginning at noon on Friday. Contestants will run in draw order. If time permits, additional exhibitions can be purchased for \$5 each at the gate with a limit of three per horse.
7. **GROUND RULES**—An electric timer will be used. If timer fails contestant will be given the option of a re-run. Penalties from original run will carry over to re-run. Ground will be raked every five entries. Western wear required including long-sleeved shirts, boots, and hats.
8. **FUTURITY PAYOUT**—The Open Futurity and the SIP Futurity Sidepot will each pay two go rounds and an average. The Futurity 2D Sidepot will have a 100% payout of added money and fees.
9. **CORONA CLASS PAYOUT**—The Open Corona and SIP Corona will be paid using a 2D format. Each division will pay two go's and an average with a 3/4 second split per go and a 1.5 second split in the average.
10. **MATURITY PAYOUT**—The Open Maturity and SIP Maturity Sidepot will be paid using a 2D format. Each division will pay two go's and an average with a 3/4 second split per go and a 1.5 second split in the average.
11. **STALLS**—Stall fees for Futurity, Maturity and Corona entries must be reserved and paid for before April 1. If aforementioned contestants plan to bring an Open horse add that horse to same form so horses can be stalled together. If payment does not accompany entry, stalls will not be held. Checks must be sent to Jaimie Mayberry. (see below) **Please indicate on stall forms if staying over from Sand Cup.**
12. **FUTURE FORTUNES**—Bonus money paid by Future Fortunes Inc. and is for Future Fortunes enrolled horses only. No additional fees. Must designate on nomination form if horse is eligible and the required Future Fortunes form must accompany entry. 14. **WESTERN FORTUNES BONUS MONEY**—Bonus money paid by Western Fortunes and available to only horses enrolled in their program. No additional fees. 15. **MARE POWER**—Bonus money paid by Mare Power and available to only horses enrolled in their program. No additional fees. Must designate on nomination form your entry in the Mare Power program.
